Mr. Dowd joined ACE in 1995 from Arkwright Mutual Insurance Company, where he spent seven years as senior underwriting officer and was responsible for underwriting primary property policies for Fortune 1000 companies and managing a staff of property underwriters.

Mr. Dowd earned a Bachelor of Science degree in finance from Northern Illinois University. He also holds the Chartered Property Casualty Underwriter (CPCU) professional designation.

LEGISLATION

In our newsletter we will try to spotlight some legislative developments which should be of interest to our members. If there are particular topics that you would like covered, please contact us and we would be happy to take your requests.

Legislative Updates

Recently, RIMS National testified before the President's Working Group on Financial Markets at the Treasury Department. RIMS reported on an informal study conducted of members regarding terrorism insurance coverage. RIMS concluded from the results of its survey that the insurance marketplace is not prepared to provide coverage for acts of terrorism without a legislatively established program in place. The risk managers surveyed believed that coverage should be available for nuclear, biological, chemical and radiological acts of terrorism, and that the private insurance market would not be able to provide coverage without some type of certainty for the ultimate amount of their loss. RIMS testified that it considers the availability of adequate terrorism coverage to be a national economic issue.

On the more local level Acting Administrative Director of the Division of Workers' Compensation Carrie Nevans commented on regulatory updates at a recent California Coalition of Workers' Compensation conference. Topics included the status of utilization review complaints, utilization review enforcement regulations, return to work regulations, lien regulations, and repackaged drug regulations. Many regulations are moving along in the process and further developments will be reported on over the next few months.

Finally, the California Fraud Assessment Commission recently approved a contract with a consulting firm to measure the extent of fraud by medical providers within the workers' compensation industry. This study is the first in a planned series of studies looking at the extent of premium fraud, uninsured employers and the underground economy.
